May HOA Quarterly Meeting Minutes

5 board members were in attendance along with 5 homeowners.

Meeting was called at 7:05PM on 5/12/15.

Items:

- 1. Contracts have been signed for landscaping and mosquito control.
- 2. Christmas lights need to be taken down by homeowners.
- 3. Trees need to be trimmed by homeowners. Can't be overhanging the road or obstructing the sidewalk.
- 4. Garbage cans are being put out too early. Shouldn't be out earlier than 24 hours before or after pickup.
- 5. There will be some changes/updates to the website soon.
- 6. Treasurer discussed being short about \$5000 for the current dues. Eighteen homes haven't paid yet. They are going to collections. Also \$19,000 has been collected in back dues and is being moved into the reserve account.
- 7. There are 8 homes in foreclosure currently.
- 8. Insurance needs to be paid for common areas. There is a new homeowner in the neighborhood that does insurance and will provide a quote for matching insurance coverage for us to review.
- 9. Vacant properties need to be maintained by banks/brokers if vacant. HOA board can report them to the Village if not being taken care of but we cannot legally mow or shovel snow on their properties. Our atty states we can issue violations and report it.
- 10. Coordinator mentioned there is a new Ordinance Officer for the Village and he is making rounds looking for violations. One area we will see increased ticketing for is parking on sidewalks.
- 11. Front entrance is having some maintaenance/repaining done. Looking into possible solar lighting again.
- 12. There is a plan to start replacing the ash trees infested with the Emerald Ash Borer. Between 16-20 will be replaced this year.
- 13. There is a plan to begin moving the front dry pond area.
