May HOA Quarterly Meeting Minutes

5 board members were in attendance along with 8 homeowners.

Meeting was called at 7:00PM on 05/10/16.

Items:

- 1. President discussed the fountain having been repaired and the precautions to prevent further damage from muskrats. Cord and lights replaced. Muskrats are still there. Would cost \$100 to set traps and \$25 to dispose of muskrats if caught.
- 2. Trailer issues discussed. RVs are acceptable in driveways, but must be moved on a weekly basis as opposed to trailer/campers which are not allowed under current rules. Anything towed behind a vehicle is considered a trailer per the attorney.
- 3. Seasonal recreational vehicles/boats are allowed in driveways between May and November as adopted by the Board.
- 4. There is a homeowner driven petition to amend the articles in the bylaws regarding recreational trailers. Procedure is as follows:
 - a. Write up the change request and must list specific details (i.e. trailer type, duration allowed in driveway, etc.)
 - b. Must have 2/3 signatures of homeowners of record.
 - i. Only one signature per home counts as a vote to approve.
 - ii. Obtain homeowner information from tax listing through McHenry Count Tax website to determine who the actual homeowners are. Renters and residents that are not on the mortgage do not count toward valid signatures
 - c. Turn proposal and signatures in to HOA Board if 2/3 requirement is met.
 - d. We send amendment proposal to attorney to write the change legally and amend the bylaw.
- 5. Vice president will be working on welcome packets for new homeowners in the neighborhood.
- 6. Secretary stated the Paypal function is closed on the website for this year's dues payments.
- 7. If there are suggestions for features desired on the website, please send them to Secretary. There are many functions that are not used. Site will undergo modifications this year.
- 8. Treasurer went over expense report.
- 9. There are 7 homeowners that are delinquent, 2 vacant homes and 5 active homeowners. In addition there is 1 pending payment.
- 10. There are 2 pending lawsuits, one foreclosure and redeemed property, and 1 foreclosure with homeowners moving out.
- 11. 96% of dues are paid this year.
- 12. 2 homeowners are still on payment plans: 1 for \$100/mo. and 1 for \$150/mo. until paid.
- 13. Coordinator discussed the park being in use this year for soccer.
- 14. Basketball post was hit by a truck and damaged.
- 15. People driving on access road.
- 16. Violations/permits/home repairs.
- 17. Floor open to comments/questions.
